1.0 Introduction:

The Uganda Bureau of Statistics (UBOS) was contracted by the Ministry of Local Government (MoLG), to undertake a survey to assess Beneficiary Participation and Accountability under the second Local Government Development Program (LGDP II), and at the same time to generate baseline information for the Local Government and Service Delivery Program (LGMSDP).

To achieve the above, a total of 1500 households were interviewed in 150 communities. UBOS commenced the assignment with submission of an Inception Report to the Client which included details of the methodology, data collection schedule and survey work plan.

2.0 Recruitment:

A total of 50 survey field staff was recruited to undertake the survey. These included 11 Supervisors and 39 interviewers. Each field team was allocated an interviewer specifically responsible for qualitative data collection.

3.0 Training:

The training of field staff commenced on 31st October 2007 and ended on 6th November 2007 (Refer to the Training Timetable in Appendix III). A participatory approach was used during training, whereby each member was expected to contribute.

4.0 Field activities

Data Collection commenced on 9th November, 2007 and was completed in a period of about three weeks. Each field team carried the following set of instruments:

- Listing questionnaire
- Household questionnaire
- Community FGD checklist
- HLG checklist
- CSOs checklist.

5.0 Team supervision and Quality control

To ensure the quality of work, a team of senior officials from UBOS conducted field spot checks. This enabled improvement on accuracy and consistency of the data collected.

6.0 Survey Coverage:

The survey covered 9 Municipalities, 62 “Old” Districts and 13 “New” Districts. A total of 1500 households in 150 villages were selected for interview. Ten households were interviewed per village. In addition, 33 Key Informant Interviews were conducted at Higher Local Government level (HLG), 34 Key Informant Interviews at Lower Local Government level (LLG), 30 interviews with Civil society organizations (CSOs) and 35 interviews with Private Firms (PFs). Details are shown in Appendix I.

7.0 Non-response:

A total of 1486 out of the intended 1500 households were fully covered. Only 14 households were not interviewed. The major reason for the non-response was failure to trace household members at home despite several call backs. There were also cases of respondents who stubbornly refused to be interviewed.

8.0 Challenges:

The major challenge faced was that the respondents had a problem of differentiating LGDP II projects from other projects of Government or Non Government Organizations at the community level.
